RE: PH TECH claims processing; ERD specific claims

Umpqua Health (UH) recognizes the need to provide necessary family planning services for the community while respecting our ownership by Mercy Medical Center and its commitment to practice and maintain good standing with the Catholic health system's Ethical and Religious Directives (ERDs).

As you may recall, earlier this year, UH expanded the CPT and diagnosis code sets from what we had previously followed under the ERDs, but required a separate claims submittal process for ERD-specific claims. Please refer to the current lists attached as Appendix 1 and 2 for CPT and diagnosis code sets.

We are pleased to announce that beginning December 16, 2017, UHA's new third party administrator, PH TECH, will begin receiving and processing all claims, including ERD claims through CIM (Clinical Integration Manager). EOBs can be viewed through CIM and electronic payments (EFT) can also be received through PaySpan. No prior authorizations (PA) will be required for ERD services.
