#### Call to Order

The meeting was called to order by Bart Bruns, UHA Board Chair, at 6:30 am.

I. Consent Agenda

#### The following items were presented on the consent agenda:

- Minutes from the September 22, 2020 UHA Board meeting
- Ratify New Board Member: Brenda Tibbetts

## The motion was made by Neal Brown, and seconded by Chuck Chappell, to approve the Consent Agenda. The motion passed unanimously.

II. 2021 UHA Operating and Capital Budget



Keith presented the UHA 2021 Budget, as approved by the UHA Finance Committee, and recommended for approval to the UHA Board. Keith discussed the major assumptions and highlights, which include conservative member estimate of 30,000 monthly, an interim rate increase of .4% in 2020, 3-4% increase in the first 6 months of 2021 (this may change depending on economic factors), preservation of the VBP compensation (contingent upon receiving this income), 10% to UHM as Administrative Fee, staying within the OHA mandated 3.4% annual rate of growth, and a new feature of the Risk Withhold Bonus.

The 2021 budgeted revenues are \$165M, \$147M in healthcare expenses, and \$1.6M in EBITDA.

There are no capital expenses budgeted in 2021.

## III. Reports

### Subcommittee Reports

## Community Advisory Council (CAC)

Jerry O'Sullivan, CAC Chair, reported on the CAC's role in the Umpqua Identity (submitters) conference, as well as the CAC's work in the 4<sup>th</sup> quarter, including releasing the CHIP application to the community, reviewing and selecting community based organizations funding requests, participating in the Community Health Assessment.

#### Delivery System Advisory Committee

KC Bolton, DSAC Co-Chair, reported the following quarterly highlights of the Committee:

- Working within the Quality Metric Review Subcommittee, finalizing 2020 incentive pool payment methodology and beginning discussions for 2021 methodology
- After input from the committee members, revised the Provider Risk Model for 2021
- Roundtable updates from each participating provider group

#### Finance

Chuck Chappell, Finance Co-Chair, reported the following quarterly highlights of the Committee:

• Met 2 times in the quarter



- Review year-to-date financial performance to understand fluctuations in income and the related impact to the financial KPI's
- Review other investment opportunities (to obtain better rates than CD's)
- MACS/NPR reporting to understand performance

## Health Equity

Sharon Stanphill reported the following quarterly highlights of the Committee:

- Presentation by CEO of Cow Creek Band of Umpqua Indians on culture, self-governance and equity of tribal members
- Focus group to review and evaluate the Health Equity Plan
- Final Health Equity Plan to be shared with the Board

## IV. CEO Report

Brent Eichman, CEO, presented on the following:

- UHA HIT Bonus
  - The Bonus was introduced to continue providing some form of financial assistance to providers; expands to the entire network
  - Commitment to OHA as part of UHA CCO 2.0 HIT Roadmap
  - Has a set of criteria and set awards
  - UHA Executive Committee voted to recommend implementing gating criteria for 2020, contingent on UHA meeting year end global budget targets, and maintain the current criteria for 2021, as well as implementing a task force to focus on identifying and resolving barriers to HIT adoption
- 2021-2023 Governors Proposed Budget
  - Budget is a bi-annual process, which covers 2021-2023, starting July 1, 2021
  - Impacts to UHA and Douglas County
    - Reduces CCO Quality Pool Funding
    - Reduces CCO global budget inflationary target from 3.4% to 2.9%
    - Assumes value based payment savings of 1% in hospital spending in OHP
    - Reduces DRG hospital reimbursement rates from 80% Medicare to 76% of Medicare



 Total impact to CCO and local provider community estimated at \$3.25M per year or \$6.5M over 2-year biennium

## VI. UHA Health Equity Plan

Dr. Tanveer Bokhari, UHA's VP of Quality and Health Equity, provided an overview of health equity, the components/implementation areas of UHA's Health Equity Plan, the implementation framework, the cross-organizational framework of UHA's Health Equity Committee, and the Member Engagement & Health Equity Committee, and their involvement in the review and feedback of the plan.

## VII. UHA Board Cultural Competency Training

Ignatius Bau provided cultural competency training, highlights include an overview of cultural competency, rationale for cultural competence interventions, putting it into practice, providing trauma-informed care, use of medical interpreters, and working with Native American Tribal Members.

#### 2021 Operating Budget

The motion was made by Chuck Chappell, seconded by Dr. Greg Brigham, to approve the UHA 2021 Operating Budget. The motion passed unanimously.

UHA Health Equity Plan

The motion was made by Tim Freeman, seconded by Jerry O'Sullivan, to approve the UHA Health Equity Plan. The motion passed unanimously.

HIT Bonus



The motion was made by Dr. Mike Krnacik, seconded by Neal Brown, to approve the HIT Bonus Program, as outlined earlier in the meeting, with the 2020 gating criteria and 2021 with the original criteria, pending year end financials. The motion passed unanimously.
