CONNECT OREGON AND CARE TELEHEALTH UPDATE **COORDINATION REFERRALS**

Umpqua Health Alliance (UHA) is excited to announce the use of Connect Oregon's referral platform *Unite Us* for receiving care coordination referrals. Connect Oregon is a coordinated care network of health and social service organizations. Partners in the network are connected through Unite Us' shared technology platform, which enables them to send and receive electronic referrals, address people's social needs, and improve health across communities.

Currently. UHA receives care coordination referrals via phone, fax, or email. Submissions via Unite Us make it easier to refer and connect to local resources. This will also increase efficiency, track outcomes and better identify gaps by proactively addressing barriers to care. - Telehealth-only providers must hold an OR license to practice and be enrolled with OHA.
- Additional Clarity on Telehealth for COA providers: only licensed staff will be able to provide telehealthonly services. Unlicensed staff within the COA will need to also provide in person.
- There must be a referral pathway for members who need, or prefer, in-person services.

ASAM IMPLEMENTATION: published revised final rules, effective April 7, 2023

There is a six-month grace period from the OAR effective date for providers to come into compliance with final rule. See graphic below.

- Practices will be required to apply for state approval at each ASAM LOC rendered (outpatient, intensive outpatient, detox, residential, etc.).
- OHA and/or HSD will conduct renewal reviews for ongoing fidelity and compliance.

CLINICAL CORNER

ALLERGY SEASON

As we enjoy summer in Douglas County, Oregon, it is important to stay informed about seasonal allergies and help our patients manage them effectively. We will focus on the reasons for allergies, common symptoms, patient education practices specific to our region, and the options covered by UHA.

Pollen Allergies in Douglas County:

Pollen from grasses, trees (like oak, maple, and pine), and weeds is abundant in our area. Pollen seasons typically begin in late February or early March and peak in spring and fall. Stay updated with local pollen forecasts through reliable sources like weather websites or the National Allergy Bureau (NAB).


Recognizing Allergy Symptoms:

Common symptoms of seasonal allergies include sneezing, nasal congestion, runny or itchy nose, watery or itchy eyes, coughing, wheezing, shortness of breath, fatigue, headache, and impaired concentration.

Patient Education and Practices:

Empower patients to manage their allergies with the following practices:

- Check pollen forecasts regularly and plan outdoor activities accordingly.
- Shower and change clothes after spending time outdoors to minimize pollen exposure.
- Use saline nasal rinses to clear nasal passages.
- Wear sunglasses to protect eyes from pollen.



 Maintain good indoor air quality through proper ventilation and air filtration.

UHA's Coverage:

UHA offers various options to help reduce allergy symptoms without needing a prior authorization. Any medication not on our formulary will require a prior authorization.

- Formulary options include:
 - cetirizine tablets
 - cetirizine 1 mg/mL solution
 - fexofenadine tablets
 - loratadine tablets
 - loratadine 5 mg/mL solution
 - fluticasone propionate 50 mcg/mL nasal spray

ON THE LOOKOUT

One of the beautiful attributes of Douglas County is its clean, fresh air in comparison to more urban areas in the State. We recognize and celebrate clean air for National Clean Air Month in May. Oregon's wildfire season is approaching though, and our clean air could become smoky. Wildfire smoke, a mixture of fine particles and gases, can be dangerous when inhaled.

The particulate matter (PM) in smoke poses the biggest risk to health. Larger particles, over 10 micrometers, usually cause eye, nose, and throat irritation. Fine particles, those 2.5 micrometers and smaller (PM2.5), can be inhaled deeply into the lungs and cause greater health concerns. People with chronic heart or lung disease such as asthma or COPD may be more likely to suffer serious health effects from wildfire smoke.

Prepare your vulnerable patients now for possible wildfire smoke this summer. Share Air Quality Index sites/apps like Oregon Air, where PM levels may be easily monitored, and ask patients to watch for alerts and warnings about smoke conditions. Additional steps during smoke events, such as staying indoors with windows and doors closed, running air conditioning (if available) with the fresh-air intake closed, and using indoor HEPA air-cleaning filters will help. Additionally, reducing or eliminating other sources of indoor smoke and dust such as from tobacco, candles, and vacuum cleaners, is good advice.

DENTAL DIGEST

ELECTRIC TOOTHBRUSH PILOT PROGRAM

As part of its Health-Related Services program, Advantage Dental Services (Advantage DCO) may provide electric toothbrushes to special populations within its UHA membership as part of a pilot program running from June 1, 2023 to July 31, 2023.

Electric toothbrushes may be provided to diabetic members with periodontal disease, non-diabetic members with Stage III or IV periodontal disease, and members with limited mobility issues in their hands or manual dexterity problems that prevent them from managing their oral hygiene with a manual toothbrush. Contributing conditions may include, but are not limited to MS, cerebral palsy, or Parkinson's disease.



The determination for eligibility will be at the discretion of the member's Primary Care Dentist (PCD) based on evaluation. If you have a patient that you think may be eligible, please have them contact their PCD. If they do not know who their PCD is, please refer them to our Member Services team at 1-866-268-9631.

CME FOR THEE

SUBSTANCE USE DISORDERS AND ADDICTION EDUCATION TO MEET NEW DEA REQUIREMENTS

On December 29, 2022, the Consolidated Appropriations Act of 2023 enacted a new one-time requirement which goes into effect as of June, 27, 2023 for any Drug Enforcement Administration (DEA)-registered practitioner (except for veterinarians) to complete eight hours of training "on the treatment and management of patients with opioid or other substance use disorders."

Many U.S. states already require physicians and other medical professionals to complete CME hours on safer prescribing of opioids. This new requirement asks physicians to have additional education on the treatment and management of patients with opioid or other substance use disorders. If you have not met this specific eighthour training requirement yet, the deadline to do so is the date of a practitioner's next scheduled DEA registration submission.

This requirement is for DEA-registered practitioners who are renewing their license or any first-time registrants (except for practitioners who are solely veterinarians).

You are considered to have already satisfied this requirement if you are:

- board certified in addiction medicine or addiction psychiatry by the American Board of Medical Specialties, the American Board of Addiction Medicine or the American Osteopathic Association
- a graduate in good standing from a U.S. medical, dental, physician assistant or advanced practice nursing school within five years of June 27, 2023, who successfully completed eight hours of training on treating and managing patient with treating and managing patients with opioid and other substance use disorders, including the appropriate clinical use of all drugs approved by the Food and Drug Administration for the treatment of a substance use disorder

Practitioners can count past trainings from relevant providers including the DATA-2000 Waiver training, toward the eight-hour requirement.

The **AMA Ed Hub** offers a variety of educational activities to help physicians and other practitioners complete their eight hours of training. It's important to note that the education requirement refers to substance use disorders, not exclusively opioid use disorder, and the training does not have to occur in one session.
