<p>B. HYSI Update</p>	<p>Thomas McGregor shared information about the history of youth homelessness in Douglas County, and the data that HYSI has regarding youth homelessness. Thomas also shared updates on some of the work being done to address youth homelessness, and Melanie shared information on work being done to establish a youth housing campus, and the ways they're working to empower young people. There was a call for help on the committee to work on the youth housing campus, which recently received grants (including SHARE funding). Thomas: there is no provider for crisis services for unaccompanied minors in Douglas County. Sarah: what do you do? Melanie: there's a program through Hearts with a Mission, Safe Families that is organizing an effort to have a youth go to someone's house, but it's not established yet.
