## Frequently Asked Questions: SHARE Grant Funding 2025



### What is the SHARE?

SHARE Defined: Supporting Health for All through Reinvestment Initiative

SHARE (Supporting Health for All through Reinvestment) is a program established by the Oregon Health Authority that requires Coordinated Care Organizations (CCOs) to reinvest a portion of their net income back into their communities. The goal is to address health equity, social determinants of health, and improve overall well-being by funding community-driven projects that create lasting impact.



#### How much funding is available?

Funding availability varies each grant cycle. In 2025, UHA will invest a total of \$1.6 million to support projects that are in our service area.



### What is the timeline for applying?

- Guidance begins: May 30 2025
  - Request for application opens: July 1, 2025
  - Applications due: August 29, 2025
  - Award announcements: By October 31, 2025
  - Funding distributed: Before December 31, 2025



### What are the requirements of SHARE?

Projects must align with the **Community Health Improvement Plan** and spending must fall within one of the 4 domains of Social Determinants of Health & Equity (SDOH-E):



- Economic Stability
- Neighborhood & Built Environment
- Education
- Social & Community health



## What are the key requirements for a successful application?

A strong application should: Clearly align with CHP strategies, demonstrate measurable community impact, show collaboration with other organizations, include a well-defined budget & sustainability plan

# Frequently Asked Questions: CHP Spring Funding 2025



### Are there any restrictions to these funds?

Yes, under OAR 410-141-3845, these funds can't be used for

 Wages, marketing, covered services for OHP members, administration activities or equipment for medical need, workforce certification training, UHA contractual requirements, & other less common items, (see OHA guidance for more details).



### Will this year's application be different? How can I receive an application?

This year's SHARE grant process is getting a creative refresh! The application will look very different from years past, with a new format designed to spark collaboration and storytelling. Details will be officially unveiled at the Umpqua SHARE Your Vision Café on June 25th.



If you're interested in applying-or just curious about what's new-you won't want to miss this exciting event. Join us to learn more, connect with potential partners, and get inspired by the possibilities for community impact.

## How is SHARE grant funding different from CHP Grant funding?

The SHARE spending plan for investments must fall within SDOH-E domains and include spending toward a statewide housing priority. Unlike CHP grant funding, capital spending is allowed.



### How are applications reviewed and scored?

Applications are reviewed first by UHA Team Community and then sent to the UHA Board of Directors for voting and selection. Evaluations are based on alignment with CHP priorities, UHA priorities, long-term impact to community, sustainability, collaboration, geographic location, inclusivity, equity, clarity of measurable goals, and use evidence based criteria. UHA shall designate a role for the CAC related to SHARE Initiative spending decisions.



### Are there examples of previous SHARE awarded projects?

- To the City of Roseburg for the Gary Leif Navigation Center, \$75,000
- To Umpqua Valley Tennis Center for Court Renovation, \$100,000
- To UCC for Construction of a multifunctional facility that includes Health Career Programs, \$1,000,000
